2021 financial statements. All members reviewed the statements and the motion

carried.

Accounts: Checking account balance (as of 6/30/21) = \$184.687.57

W/S Savings account balance (as of 6/30/21) = \$96,334.90

## **Business Meeting:**

**Past Due:** Through June 30th, we collected \$23,681.37 on past due Assessments.

Church Road: McKee and Rivers shared with the others about the meeting at the church. The church meeting ended with two questions proposed: 1. If the church paid to fix the road, could they not pay assessments to that same amount?. 2. Could they work on it without owning it? After much discussion, the board decided that, as of right now, the association could not pay for the work they are wanting done. Until the repair of the dam is complete, there should be no commitment to spending a large chunk of money on anything. As done in the church meeting, the road was offered to be deeded to the church with them paying all fees associated with the transfer of ownership. They declined.

**Property Liens:** Updated look at letter that will be going out.

**Grant:** The DEQ has recently created a grant program that can help pay for part of the costs of the dam. The application has already been started.
