- SEPM has finished fertilizing the lake for the year. We will start back in March. Early
 October clarity levels showed the bloom to be at 24" for most of the month. In late
 October the readings averaged 30". SEPM fertilized the last week of October.
- The Lake Improvement Committee met jointly with members of the Security Committee and 3 Ms. game wardens and the sheriff of Jasper County. We got great information concerning how to approach boaters and how to handle requests for assistance from the sheriff and game wardens. We also got assurance from them that if we call them for assistance they will respond.
